## **ORDER**

To

Sub: "Restoration in intake for A/Y 2016-17" in respect of SRI VENKATESWARA ENGINEERING COLLEGE, NH-09 AMARVADI NAGAR, SURYAPET, NALGONDA, TELANGANA – 508 213 – Reg.

- 1. Whereas, the AICTE is a statutory body established by AICTE Act, 1987 to provide for establishment of an All India Council for Technical Education with a view to the proper planning and co-ordinate development of the technical education system throughout the country, the promotion of qualitative improvement of such education in relation to planned quantitative growth and the regulation of proper maintenance of norms and standards in the technical education system and for matters connected therewith.
- 2. Whereas, Section 10 of the AICTE Act prescribes the function of the Council and mandates that it shall be the duty of the Council to take all necessary steps and it may think fit for ensuring coordinated and integrated development of technical education and maintenance of standards, Section 10 (k) of the AICTE Act, empowers the AICTE to grant approval for starting new Technical Institutions and for introduction of new courses or programmes in consultation with the agencies concerned and Section 10 (q) empowers the AICTE to withhold or discontinue grants in respect of courses, programmes to such technical institutions which fail to comply with the directions given by the Council within the stipulated period of time and take such other steps as may be necessary for ensuring compliance of the directions of the Council.
- 3. Whereas, in order to discharge its duties in accordance with the provisions contained in the AICTE Act the AICTE has framed the regulations for grant of approval for starting new Technical Intuitions, introduction of courses or programmes and increase / variation of intake capacity of seats for the courses or programmes of existing Technical Institutions. The AICTE has also evolved a Hand book for approval process which details out the procedure as well as minimum conditions which an Institute must fulfill in order to seek approval for either starting new Technical Institutions or for introduction of courses / programmes as increase / variation of intake capacity of seat for courses / programmes as well as existing Technical Institute.
- 4. Whereas, based on the recommendation of Standing Appellate Committee, the Institute namely SRI VENKATESWARA ENGINEERING COLLEGE, NH-09 AMARVADI NAGAR, SURYAPET, NALGONDA, TELANGANA 508 213 was given Zero admission in B.Tech (Civil Engineering) and M.Tech (Power Engineering) and 20% reduction in intake in M.Tech (CSE) and M.Tech (VLSI) vide ORDER dated 01.9.2015.

- 6. Whereas, the matter was placed before Standing Appellate Committee (SAC) on 19.04.2016. The institute's representatives were also **present** before the SAC. The observations and recommendations of SAC are as follow:-
  - " EVC report dated 05.04.2016 contains the programmes for which inspection was held. EOA is recommended for A. Y. 2016-17 for these programmes.
- 7. Therefore, after examining the entire matter in the facts and circumstances mentioned herein above, and based on the recommendation of the SAC dated 19.04.2016, the Council has decided to give Extension of Approval for the A. Y. 2016-17 for the programmes mentioned in para 4 of this order to SRI VENKATESWARA ENGINEERING COLLEGE, NH-09 AMARVADI NAGAR, SURYAPET, NALGONDA, TELANGANA 508 213.
